Dues Schedule

Note: This translation is for informational purposes only and has no legal effect; the binding dues schedule of the organization is the original German version of the current "Beitragsordnung"

- [1.] The fee for membership is structured as follows:
 - Regular membership dues are 96 € per calendar year.
 - Reduced-fee membership dues are 50 € per calendar year. The following persons qualify for reducedfee membership: sponsors, students, persons in their voluntary social year (FSJ), persons in their voluntary ecological year (FÖJ), federal volunteers, trainees, persons without earned income, official recipients of basic social benefits, and official recipients of a pension due to reduced earning capacity.
 - Membership dues for legal entities are 150 € per calendar year.

In cases of hardship or special circumstances, the Board of Directors may, at the request of the member, decide to reduce, defer, or change the due date of the membership fee.

- [2.] The membership fee can be paid as follows:
 - in cash to the Treasurer of the organization;
 - by bank transfer to the organization's bank account; or
 - by automatic debit by an authorization for SEPA-debit.
- [3.] For members who are members of the organization on January 1 of each year, the membership fee is due on January 31 of the calendar year. If the membership fee has not been paid by March 31st and after a written notice by the board, if the member does not pay within the 4 weeks of the notice, the member will be charged a 10 € late fee.
- [4.] If the member has authorized payment via a SEPA-debit, the membership fee will be collected on the last banking day in January each year. Bank charges for unsuccessful SEPA-debits are at the member's expense.
- The reduced membership fee must be requested and proved. The request must be made no later than January 10 of [5.] the current membership year or at the beginning of a new membership. The reduced membership fees is valid only for the one year in which the reduced membership fee is to apply. A cash refund, credit, or a retroactive exemption from dues is not possible.
- [6.] Members joining the organization during the year shall pay one quarter of the annual dues per quarter, due 14 calendar days after the date of joining, starting from the quarter in which the date of joining falls. In the event of late payment, point (3) shall apply mutatis mutandis. The organization does not charge a joining fee.
- [7.] If a member leaves the organization before the end of the calendar year, the membership fee will not be refunded, not even on a pro rata basis.

This dues schedule shall take effect from January 1, 2024, at which time, the dues schedule of May 7, 2013 shall expire.

This amended dues schedule of the Schwul-Lesbischer Sportverein "Der Bogenschütze" Dresden e.V. was adopted by a majority vote at the annual meeting on March 26, 2023.
